SUPPLEMENTAL RELEASE & WAIVER OF LIABILITY ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

IN CONSIDERATION of being permitted participant to compete, officiate, observe, work for, or participate in any way in the above event and/or activities and /or being permitted to enter for any purpose any RESTRICTED AREA (defined as any area requiring special authorization, credentials or permission to enter or any area to which admission by the general public is restricted or prohibited, including but not limited to the competition area and any hot pit or paddock area. EACH OF THE UNDERSIGNED for himself/herself, his/her personal representatives, heirs and next of kin agrees that.

1. Acknowledges, agrees and represents that he/she has or will immediately upon entering any such RESTRICTED AREA, and will continuously thereafter inspect the RESTRICTED AREA which he enters and he further agrees and warrants that if at any time the RESTRICTED AREA they believe something to be unsafe, it will be brought to the attention of an official, and they will removed themselves from the RESTRICTED AREA and leave the RESTRICTED AREA prior to the event.
2. HEREBY release, waive discharge, and covenant not to sue the promoters, participants, racing associations, sanctioning or administrative organizations or any affiliated entities thereof, track operators, track owners, officials, car owners, drivers, pit crews, all persons in any RESTRICTED AREA, sponsors, advertisers, owners, lessors and lessees of premises used to conduct the Event, premises and event inspectors, surveyors, underwriters, brokers, consultants and others who gave recommendations, direction or instructions or engage in risk evaluation or loss control activities regarding the premises or EVENTS and for each of them, their directors, officers agents and employees (all for the purposes herein referred to as (Releasees). From all liability to ourselves, the undersigned, our personal representatives, assigns, executors, heirs and next of kin for any and all claims, demands, losses or damages of the MINOR and/or parent or guardian on account of any injury, including, but not limited to the death or injury of the parent/guardian or MINOR or damage to property all of which is caused or alleged to be caused by the negligence of the Releasees or otherwise.
3. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS and RELEASEES and each of them FROM ANY LOSS, LIABILITY, DAMAGE, OR COST INCLUDING BODILY INJURY OR PROPERTY DAMAGE they may incur arising out of my presence or participation in the EVENTS whether caused by the NEGLIGENCE OF THE RELEASEES or otherwise.
4. HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY DEATH OR PROPERTY DAMAGE arising out of or related to the EVENTS whether caused by the NEGLIGENCE OF THE RELEASEES or otherwise.
5. HEREBY acknowledges that THE ACTIVITIES OF THE EVENTS ARE VERY DANGEROUS and involve the risk of serious injury and/or death and/or property damage. Each of the UNDERSIGNED also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.
6. HEREBY agrees that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreements extends to all acts of negligence by the RELEASEES, INCLUDING NEGLIGENT RESCUE OPERATIONS and it intended to be as broad and inclusive as is permitted by the laws of the Province or State in which the EVENTS is/are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall notwithstanding continue in full legal force and effect.
